### **Tree Tips**

Ahh Spring, that wonderful season when the days begin getting longer, the flowers begin to bloom and the landscapers and tree companies begin their seasonal barrage of door litter that they call advertising.


While I'm all for supporting the entrepreneurial spirit of these individuals, I am also concerned about some of the services I see being offered, primarily as it relates to tree services. There are several things any homeowner should be aware of before hiring someone to do work on their trees.



First, <u>ASK FOR PROOF OF INSURANCE</u> and then phone the insurance company if you are not satisfied. A reputable arborist carries personal and property damage insurance as well as workers' compensation insurance. Many homeowners have had to pay out large amounts of money for damages caused by uninsured individuals claiming to be tree experts. You could be held responsible for damages and injuries that occur as a result of the job.

Second, **DON'T TOP YOUR TREES** (or hire anyone that will)! If you feel that you need to top your trees, please do yourself a favor and just remove it. Space won't allow a full discussion of why but rest assured, it is ugly, unhealthy for the tree, not practiced by professionals in the industry and will create more long-term maintenance and safety issues than it solves. Third, MULCH WIDE, NOT DEEP. We've all heard too much of a good thing can be bad. This also care, specifically mulching. Trees can benefit proper mulching. However, they can suffer just as apply it incorrectly. As a general rule of thumb, a 3-organic mulch spread evenly under the canopy of touching the trunk is appropriate. Trees are valuable landscape assets. They provide beauty and shade, along with a number of social, environmental, community, and economic benefits including increased property values. For these reasons, they require an investment of time, money and expertise for the proper selection, planting, care, maintenance and removal. Please keep these tips in mind the next time you hire a tree or landscape service.

#### **Woodland Pass Entrance to Whitehills**

Our neighborhood association president, Roberta McElmurry, has volunteered to adopt the median at the intersection of Abbott Road and Woodland Pass, but needs the assistance of interested, energetic homeowners who are invested in making our neighborhood bloom. Many have inquired why the WNAEL doesn't mow and manage that entrance. The answer is that it is not within our boundaries. The City of East Lansing is responsible for maintaining the median, but that is not going to happen in this time of budget shortages.

Besides the hands-on-the-ground assistance of volunteers, Roberta reports that the following is needed: (1) contribution of perennials; (2) landscaping donations to purchase shrubs and mulch for the entrance; (3) <u>all</u> homeowners paying their dues so that the Whitehills Neighborhood Association can add to the funds for the general landscaping budget; (4) help with establishing a "Whitehills Estates" sign on Woodland Pass – we need designers, fundraisers, and installers!

#### **Ever wonder what your dues money is used for?**

Our neighborhood has over 420 homes. Each household has the opportunity to become a member for a mere \$40. Your dues are utilized in a number of ways:

- To provide you with an informative newsletter and website (<a href="www.wnael.com">www.wnael.com</a>) to keep you up-to-date on what is happening in the neighborhood.
- To provide you with safety through our Neighborhood Watch program. Neighbors can notify the board of any unusual activities and that information is blasted out to paid members.
- When specific issues arise, such as restructuring our schools, your association organizes special task force groups to fight for what's best for our neighbors and community.
- To offset the costs of keeping our neighborhood entrances looking attractive.
- To provide members (you and your family) with fun activities so you can get to know your neighbors.

The role of your neighborhood association is an important one. You get all this and more. You get a board that is dedicated to keeping our neighborhood informed, safe and attractive.

## **The Wall That Surrounds Us**

One of the attractive features of our neighborhood is the distinctive brick wall that surrounds us. It provides the neighborhood with safety, reduces sound and gives the entrances a distinctive look. BUT, did you know that if the wall decays or collapses, it is the responsibility of the homeowner on the property that it meets to cover repair costs and to do so in a style and manner that replicates the original wall structure.

It is recommended that if you have a brick featured wall touching your property that you remove trees that are within 6' of it. If not, the root system will eventually disrupt the fence, causing it to collapse, as a section of the Lake Lansing wall did last year.

The fence entrance areas are the responsibility of the association. Currently, on Foxcroft, the garden/fence area is in great need of repair. The neighborhood association is reviewing bids to repair the damage before the fence collapse.



#### **Foxcroft Entrance Repairs Badly Needed**

The east entrance wall at north Foxcroft is crumbling and the light cannot be made operational until the wall is repaired. So far, the WNA has sought several bids, and it looks as if the cost will be between \$4,000 and \$5,000. Fewer than 200 homeowners have paid 2011 dues out of over 450 households. This does not provide sufficient funds for taking care of major projects, yet everyone who lives here benefits from the diligent maintenance of neighborhood entrances. The majority of the annual budget is utilized in tending entrances and common areas. The WNA is attempting to save enough to repair the crumbling walls, maintain our current level of entrance appeal and establish a new entrance sign on Woodland Pass. Every residence's payment of annual dues will make this possible. If you have not yet participated by paying your dues, send a check for \$40 to our treasurer, Kathy Daugherty. #### **Keeping Up Appearances**

With the long, dark winter months ended, there is a flurry of activity in the neighborhood as homeowners mow, weed, seed, plant, window wash, trim trees, reroof and otherwise take care of and improve their properties. A few things bear repeating, all of which are addressed in the contractual covenants that bind your property:

All trash containers must be placed in completely enclosed storage areas (i.e. garages) after weekly trash collection. This is not only a property covenant, but a City of East Lansing ordinance. Chronic violators will be fined.

Tempting as it might be, homeowners are not allowed to keep RVs, commercial vehicles, trailers, boats, wave runners, tractors or other such items on their property, unless stored in a completely enclosed and permitted storage unit such as a garage.

If you have plans to re-landscape, build a deck, install a fence, pool house or pool, or expand the footprint of your home, you must submit your plans to the WNA Covenants/Pride committee for assurance that your home improvement projects fall within the provisions of the covenants that apply to your property. It is not sufficient to have a building permit from the City of East Lansing. Grantor approval from the WNA is also required.

Please submit your proposed plans, or bring any neighborhood covenant issues, to Thomas Jones, 1625 Hitching Post Road, 517-332-1683. Drop off your plans well in advance of project commencement to avoid the complications and expenses that can result when projects are not in compliance with applicable covenants.
